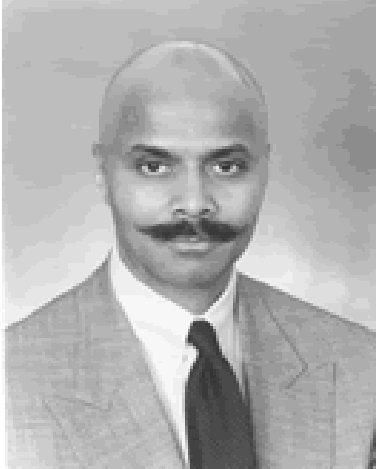
CONNECTION:
